

North Carolina

The NC OAH is participating in the planning of the Fourth Southeastern Health Planning Symposium which is scheduled to be held in Columbia, SC in September 2012. The Symposium has members from NC, SC, GA, FL and TN. This year's conference will focus on policymaking, and the historical effects of health care regulation on urban and rural communities. The current national debate toward continuation of traditional Certificate of Need laws makes this a timely topic in a region that shares legal, cultural and health care philosophies.

This multistate perspective forms the basis for NC's incentive to create a southern regional NAALJ affiliate composed of both state and federal administrative law judges. Focusing on the commonalities of regional philosophies, such as the regional policy debate concerning hospital CON, NC will urge NAALJ to create a broad professional regional organization that will strengthen the policies that underlie the practice of administrative law on both the state and federal level and will urge NAALJ to consider, debate, and adopt resolutions that reflect the development of informed national administrative law policies. If this regional approach proves to be successful, NC invites other regions to petition NAALJ to form similar affiliates.

Over the last two years regulatory reform measures enacted by NC's General Assembly have focused primarily on agency rulemaking that emphasizes regulatory clarity, authority, necessity and costs. In the area of Medicaid and other administrative hearings, several new legislative initiatives addressed fairness, balance and finality in administrative hearing procedures.

The use of mediated settlement conferences for all types of contested cases has increased and shown the efficacy of this form of dispute resolution. Most notably in the area of Medicaid appeals, mediations have resolved eighty percent or more of all contested cases referred.

2012 Mid-Year Conference in Reno, Nevada

The 2012 NAALJ Mid-Year was held on April 1-3 at the National Judicial College located on the campus of the University of Nevada - Reno. The National Judicial College, hereafter referred to as the NJC, was a co-



sponsor of this event. It's been decades since a NAALJ conference convened in Reno, and high time it finally happened. Although no specific theme was announced by the conference's organizers and sponsors, NAALJ Secretariat Bev Thomas set the mood for this event by coining the slogan "NAALJ goes to college," inviting both NJC first time attendees and veteran alumni to attend. However, from the Sunday night opening reception at the Wild River Grille to the presentation of our NJC completion certificates on Wednesday afternoon, the whole event sure felt like a homecoming to this NJC alumnus.

This year's Mid-Year promised to be a unique event. After all, NAALJ and NJC have much common history. The conference planners, NAALJ Past President and present NJC faculty member Steve Wise and NJC Program Attorney Susan Conyers, made sure we had an old-fashioned quality education program to be held on the premises of the NJC, specifically rooms (pre-2000) 103 and (post-2000) 1245, a mix of the old and the new. Even the conference "faculty" (as listed on the official NJC faculty roster) had an old/new feel to it, with NJC faculty, NAALJ members, and some new, to us, speakers combining to deliver the two-day program. We got a peek at the direction future conferences may be headed in the "Technology for Breakfast" presentations at Monday's and Tuesday's breakfasts by the conference's Gold and Silver sponsors, Sustain Technologies, Inc. and Infocom Systems Services, Inc. Attendees learned about better management using technology while we drank coffee, nibbled fruit, and chewed bagels.

Admittedly, April in Reno is not the best time of year for sightseeing. Cold and blustery winds are a feature of early April there, and we were not disappointed. Still, the sunny days made for great walking weather, so some of us seized the opportunity for invigorating morning and afternoon walks through the university campus to and from NJC and our rooms at the Silver Legacy Casino and Hotel. The good news was that Silver Legacy rooms went for the prevailing NJC attendee rate of \$49.00. The better news was that the rooms appeared to have been recently renovated; my room was in much better condition than the Silver Legacy room assigned to me during my last NJC class in 2009. In this instance, the reality was better than my memories.

So conference attendees got a full dose of the NJC experience; 50 minute classes/sessions, end of class bells, sitting in the old lecture hall, and stalking the plaque covered NJC halls. Why, even the bookstore was open. Every day we had breakfast and lunch at the NJC dining room where dining arrangements haven't changed and the food is the same as always–plenty of it. For old-timers like me, interested to see what has changed in Reno, a walk downtown was eye-opening. Some changes I noted were for the better, like Reno's new rapid transit system center, while others were not–too many empty storefronts in front of the casinos on Virginia Street. Some downtown restaurants, like Adele's, have disappeared; others, like Roxy's, remain. In his Monday morning welcoming address NJC President Bill Dressel told us that Reno is considering dropping "The biggest little city" slogan. Wonder if that means they'll knock down the arch on Virginia Street?

Monday's first presenter was NJC faculty member Elizabeth Francis, my 1998 Administrative Law Fair Hearing Judicial Writing teacher. Her remarks on decision writing are as timely now as then. Later that morning we were treated to a session from NJC Donald Reynolds Courts and Media Center faculty member Benjamin Holden covering public access, privacy, and the press. The afternoon breakout session provided a choice between a panel discussion on special education by NAALJ Board members June McKinney and Jim Murray, California ALJ Susan Ruff and Maryland ALJ Mary Shock, and two presentations, social networking by New York City Tax Appeals ALJ Anne Murphy, and "ethics, evidence, and metadata" by Las Vegas, Nevada DMV ALJ Toni Boone. Seeing as how my caseload is not special education, I opted for Murphy and Boone, and enjoyed both fact-filled presentations.

Tuesday saw more of the same as that day's program began with a breakout choice between sessions on communicating with self-represented litigants by NJC faculty member and another of my former instructors, Kelly Tait, or about complex cases by NAALJ Past President Maggie Anderson and fellow California ALJs David Benjamin, Michael Cohn, Melissa Crowell, and Jonathan Lew. Later we heard a diverting presentation on working with interpreters from two Nevada based interpreters, Andrea Krlickova and Ixtla Malagon. The conference finished with an afternoon on ethics and implicit bias by Professor Paul Paton of the University of the Pacific's McGeorge School of Law.

No trip to the NJC would be complete without a visit to Lake Tahoe. Ours was Monday evening. We were bussed over the Sierras to the north shore and the Cal-Neva resort, straddling the California-Nevada state line of course, for an optional dinner and tour. The tour centered on the resort's colorful history which had at various times been owned by bootleggers and mobsters. During the 1950s and '60s the resort became a frequent playground for the likes of Frank Sinatra, John and Bobby Kennedy, Marilyn Monroe and that crowd. We saw secret tunnels and escape routes running between the lodge, the waterfront, and some of the guesthouses, and heard about late night rendezvous among the rich and famous, dead bodies, and ghosts. All that and Frank, Jack, Bobby, and Marilyn in a single hour's tour, oh my!

So that's how NAALJ went back to college. All of the attendees I talked to enjoyed their NJC experience and many indicated to me that they would consider returning to a future conference held at this site. The conference made a profit, and with 55 participants, was well attended for a Mid-Year. Personally, I had a nice time. After all, in Reno at least I knew some of the restaurants and most of the places and things I wanted to see and do. Plus I got lucky—won three dollars on a penny slot machine while "In Reno in the Casino"—my apologies to David Spade, but I just had to work that line in somewhere.
